They will be elected at the AGM to serve as President and Treasurer, respectively, for the coming year. For those not attending the AGM, votes via the online ballot paper, e-mail, by post or hand delivery must be submitted and received by the Bursary by 4pm on Tuesday 6 February 2024. For those attending the AGM, paper ballots must be submitted by the end of the AGM. Online voting closes at 4pm on 6 February so will not be available for voting at the AGM.

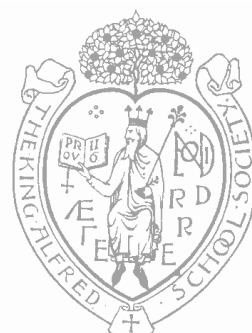
